### 4. FIRST AID MEASURES

## 5. FIRE-FIGHTING MEASURES

- Suitable extinguishing methods** : Water in mist form  
 Carbon dioxide (CO<sub>2</sub>)

- Extinguishing methods not recommended** : Direct water jet.
- Specific dangers** : Flammable liquid and vapour. Dangerous when exposed to heat or ignition source. Exposed packaging to the fire may rupture due to the increased pressure with risk of a subsequent explosion. The vapours are heavier than the air and spread close to the ground and it can move to the ignition source and provoke fire or backspace of the flames. **For staff who are not part of the emergency services** : No action should be taken that may generate danger to people without adequate training and qualifications. #### Methods and materials for containment and cleaning

Confine the spill in a dike away from the leak point for later disposal. Remove local packaging from the spills site. Preferably use anti sparking tools to collect the product. All equipment used when handling the product must be electrically grounded. Soak up with an inert dry material (sand, vermiculite) placing the same in a suitable container for later disposal - see chapter 13.

**Small spills / leaks** : Contain and collect the material of the leak with absorbent materials and non-combustible, such as sand, earth, vermiculite, calcined diatomite, etc. in a waste container in accordance with local regulations.

Stop the leak if this can be done safely. Cover up spillage in a tarp to prevent the spread by wind or rain. Use antifascantes tools and explosion-proof equipment properly grounded to collect the product. Place the material collected in dry, clean and properly identified containers.
