**fire fighting team.** contained breathing apparatus with positive pressure and full protection clothes.

**Specific methods** : Evacuate and isolate the area. Approach from fire with wind at your back. Fight the fire to a secure distance. be electrically grounded. Soak up with an inert dry material (sand, vermiculite) placing the same in a suitable container for later disposal - see chapter 13.
