

WEG Africa Electra Mining Africa 2026 Promotional Giveaway Terms and Conditions

1. Promoter

This promotional giveaway ("Promotion") is conducted by WEG Africa (Pty) Ltd ("WEG" or "the Promoter").

2. Giveaway Period

The Promotion will commence on 1 September 2026 at 00:01 and will end on 11 September 2026 at 16:59, or earlier if all available promotional gifts have been allocated, whichever occurs first.

3. Eligibility

3.1 Participation in the promotion is open to attendees of Electra Mining Africa 2026 who are 18 years of age or older and who comply with these Terms and Conditions.

3.2 Employees, directors, consultants, officers, agents, and contractors of the Promoter and its affiliated companies and their immediate family members, are not eligible to participate in the Promotion.
