## 7. HANDLING AND STORAGE

**Precautions for safe handling**

**Fire protection** : Tools that do not produce sparks should be used. Keep away from heat and sources of ignition. Do not smoke. Avoid accumulation of electrostatic charges. #### Storage conditions

**Acute toxicity**
