**4. FIRST AID MEASURES**

**Inhalation** : Take the victim to fresh air, keeping them rested and warm. If breathing is irregular or has stopped, apply artificial respiration. Do not give anything orally. Seek medical assistance immediately, bringing the product label whenever possible.

**Contact with the skin** : Remove all contaminated clothing immediately. Wash affected area with plenty of soap and water.

**7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Acute toxicity**

Powder coatings are generally inert dusts . No data are available on acute toxicity for the product. Powder coatings can cause irritation located in the skin , especially in skin folds or use of tight clothes . People allergic or respiratory problems should not work in the powder application.
