**Fire protection** : Tools that do not produce sparks should be used. Keep away from heat and sources of ignition. Do not smoke. Avoid accumulation of electrostatic charges. **Acute toxicity**

Powder coatings are generally inert dusts . No data are available on acute toxicity for the product.
