4. FIRST AID MEASURES

**of the emergency services** : people without adequate training and qualifications. Use appropriate personal protective equipment - see section 8. Evacuate surrounding areas. ## 7. HANDLING AND STORAGE

### Precautions for safe handling

**Acute toxicity**
