### 4. FIRST AID MEASURES

## 5. FIRE-FIGHTING MEASURES

professional.

#### Methods and materials for containment and cleaning

## 7. HANDLING AND STORAGE

#### Precautions for safe handling

**Precautions for safe handling** : Use individual protective equipment. Environments and areas that will be used for electrostatic spraying of powder paints must provide controlled ventilation. Through controlled ventilation it must be ensured that the air in the inhalation scope is healthy from a health point of view (see limits in Section 8). ### Storage conditions

**Substances to be avoid** : Keep away from oxidising agents, strong acid solutions and strong alkaline solutions.

**Acute toxicity**

Powder coatings are generally inert dusts . No data are available on acute toxicity for the product.
