4.2. Most important symptoms and effects, acute and delayed

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures

- : Eliminate every possible source of ignition. Prevent from entering sewers, basements and workpits, or any place where its accumulation can be dangerous. Avoid contact with skin and eyes.
