**4. FIRST AID MEASURES**

**For staff who are not part of the emergency services** : No action should be taken that may generate danger to people without adequate training and qualifications. **7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Instructions for safe treatment** : Avoid contact with eyes, skin and clothes. Do not handle the product before reading and understanding all safety precautions. Do not re-use packaging. **Precautions for safe handling** : Use individual protective equipment. Environments and areas that will be used for electrostatic spraying of powder paints must provide controlled ventilation. Through controlled ventilation it must be ensured that the air in the inhalation scope is healthy from a health point of view (see limits in Section 8). Emergency showers and eye wash basins must be installed in locations of use and storage.
